Appendix O: Review and Ranking “Tie Breaker” Policy



Myself, Jay Zupa, Emilia Rosas & Carlie Wetzel were in agreement that this was the best method to resolve a tie score during any future ranking & review process, with no response from Barbara Kreseski.

Tie Breaker Policy...

“If there should be a tie score during the ranking and review process the “Ranking & Review Committee” shall take the most recent scores from the previous program year, where a complete ranking & review process was held, and add them to the current program year score to find an average score and use that average score for the final ranking process.”
